

The Tutbury Practice Patient Forum Minutes of the Meeting Wednesday 15<sup>th</sup> January 2020 between 1pm and 3pm. Meeting held in the Village Hall, Monk Street, Tutbury.

### 1. Introduction and Welcome.

The meeting was opened by the Chair, JG, welcoming everybody present. The initial part of the meeting was the AGM and election of the Forum officers to serve throughout 2020.

(The full presentation can be found under Attachment (i) of these minutes). In addition to the above a presentation was given on the Forum finances as at 31<sup>st</sup> December 2019. Due to the confidential nature of this presentation it does not appear in the minutes. The members were in full agreement that the Chair, JG, could sign the finances as a true and correct record of income and expenditure. JG wished to thank all those members present for their input and hard work throughout 2019 and for the support shown to both her, the Deputy Chair and the Secretary. This was also echoed by the Secretary JB.

### 3. Election of Forum Officers for 2020.

In accordance with the Forum Constitution, the positions of Patient Forum Chair, Deputy Chair and Secretary are to be elected each year. Prior to the meeting nomination forms had been sent to all existing Forum and Virtual Group patient members as well as being posted on the Forum noticeboard at the outside entrance to the waiting room.

The Secretary, JB, informed the meeting that 3 nomination forms had been received. These were from the existing Chair, Deputy Chair, and Secretary. Based on the above and discussions / vote held with all those present. the following members were unanimously elected:

JG, and JB expressed their thanks for the confidence given to them by the members present.

# Representative(s) to attend the East Staffordshire District Patient Engagement Group for 2020

Currently the District Groups Chair and Vice Chair are Forum members, (SAR and JB). At last year's Patient Forum AGM, BW was also elected to stand as the Forum representative at the District Patient Engagement Group. BW is happy to continue in that role throughout 2020. To follow the democratic process the members were asked if anyone else wished to also stand. No further names were forwarded and so it was unanimously agreed for BW to continue in this role throughout 2019.

With the changes in the way health will be delivered in the future within East Staffs it is important to have representatives present at these meetings and if in the future anyone else wishes to come along they need to inform the Secretary, JB. The Chair, JG, closed the AGM and the meeting followed the normal procedure.

# 5. Approval of the Minutes from the Meeting held on 20th November 2019.

There were no issues raised on the Minutes. BW proposed approval which was seconded by BC. The Minutes were signed by the Chair, JG, as being a true record of the proceedings.

# 6. Action Log Update

# (i). Update on possible siting of a cycle rack

The racks have now been fitted. Action closed

# (ii). The Installation of a Bench outside the surgery.

As with the cycle racks the bad weather had stopped the planned installation. The bench has now been installed. Positive comments been posted on "Spotted in Tutbury" website. Action closed

The members agreed that a plaque should be fitted on the bench. The Secretary, JB, will make the necessary arrangements. **Action JB** 

# (iii). Repair of the clock within the waiting room.

The Secretary, JB, informed the members present that he had recently spoken to someone who was happy to come and give an estimate for repair. Date as yet to be arranged. Action ongoing.

# (iv). Website for the Patient Forum.

Currently the Patient Forum is part of the Tutbury Practice website and can only be updated by the Practice staff. This has meant that currently the information on it is out of date. The Secretary, JB, had spoken to both the Chair and Vice Chair on the Forum having its own independent website and had looked into the associated costs. The person who acts as our quiz master does this and his quote was very competitive. The Chair and Vice Chair had agreed this was the next logical step forward for the Patient Forum and the finances / quiz donations could support this. The members were in full agreement and work had started. The website address will be:

The ongoing cost is approx. £100 per year starting January 2021. This is an exciting development and to our knowledge the Patient Forum will be the first Patient Group in East Staffs to have its own website. The members congratulated the elected officers for setting this up. **Action ongoing.** 

### (v). Patient Survey

# 7. Practice Update.

The Practice Manager, RB, gave the following update:

# (i). Patient Registered Numbers

Our registered patient numbers have increased from 7810 at 1<sup>st</sup> November 2019, to 7898 as at 1<sup>st</sup> January 2020 an increase of 88 over the last two months.

We are still experiencing a very high demand for our services and will always try to accommodate patients as best we can however please bear with us. Staff have experienced frustrated and abusive patients over the last few weeks, but we do try and help wherever possible.

# (ii). Phlebotomy Service

Our phlebotomist has now returned to work on phased return, appointments may be limited, and we may ask those patients who can get to the hospital to attend there for blood tests leaving our appointments free for those less able to travel. We hope that normal service will be resumed shortly but thank everyone for their patience and understanding.

# (iii). Clinical Pharmacist

Our new clinical pharmacist, Judith Atherton, has now started at the Practice. Primarily she will be seeing patients for medication reviews and those patients who are newly registered with the Practice and are taking multiple medications. JA will be working on a Monday.

AG asked if JA will be doing the medicines use review currently undertaken by the Pharmacist? Not entirely due to the numbers involved.

# (iv). Staff

We have recently interviewed for an additional receptionist. Interviews went well and we hope to appoint over the next week or so.

# (v). Medication Shortages

We have over recent weeks been inundated with Medication Short Supply notices – These are e-mail notifications that inform us that some medications are either in short supply or not available for the foreseeable future. When we receive these notifications, it is necessary to look for alternative medications that we can prescribe. The Pharmacy may query medications that have been prescribed by the GP or ask us for an alternative, if this is the case and you do not receive your medication when you expect to, it may be due to the Pharmacy asking us for an appropriate alternative. We try to deal with these queries in a timely manner however this may take longer than patients are used to.

The shortage was also confirmed by KMcC, Dean and Smedley.

The Secretary, JB, indicated that with the introduction of additional pharmacy services there could be a delay in people receiving their prescription when going into a pharmacy. The reason for this is that the prescription may have been prepared but was waiting sign off by the pharmacist who maybe in the consulting room with a patient. Whilst some pharmacies may well have additional staff who can sign off the prescription others may not / going through training people so resulting in a delay. It was hoped patients would understand this.

# (vii) Telephone Calls

Over the last 2 months the number of incoming and outgoing calls had totalled 48,000! Discussion over the main reasons for this, (eg ringing for test results, appts etc). EJ asked what the system regarding test results was, from coming into the surgery, how allocated GP or not, need to contact a patient or not. RB explained the system. It was agreed that it would be useful to how a diagram on the pathway.

# (vi). Thanks

# (vii). Do Not Attends

The Secretary, JB, had the data for November and December and had presented the information during the AGM section of the meeting. This will be sent to RB. The overall results were higher than 2018 but the technical issues with the NHS could well have affected the accuracy of the results.

# (viii). Friends and Family, Figures January – October 2019

As above the Secretary, JB, had presented all the information during the AGM. This will be sent to RB.

# 8. Feedback from East Staffordshire CCG Governing Body, East Staffordshire CCG Patient Board and the East Staffordshire District Patient Engagement Group, and Virgin Care

The Forum Secretary, JB, who is the Vice Chair of both the East Staffs CCG Patient Board and the East Staffs District Patient Engagement Group, gave the following verbal feedback

# (i). The East Staffordshire CCG Governing Body.

The six Governing Bodies across Staffordshire and Stoke-on-Trent have agreed to meet in common in order to make strategic decisions that affect the whole population. The locations of these meetings have been spread across the county in order to offer access for everyone interested in attending. The meetings held in public will be alternated with confidential and Organisational Development meetings for Governing Body members to more effectively understand and work towards meeting patient needs in a rapidly changing landscape.

The next meeting will be at the Pavilion, Branston Golf Club on the 30<sup>th</sup> January, between 1.30pm and 4pm. This is the first meeting, apart from the AGM, held in

Burton since January 2019. Full details will be sent to the Forum membership.

Action: The Secretary, JB, to forward the necessary information on the above.

# (ii). Patient Board

The Patient Board met the previous day and as usual had a full Agenda.

JB was re-elected to serve as the Vice Chair for 2020. The Chair, CR, who also sits as Patient Lay Member on the East Staffs CCG Governing Body, will be stepping down during February. This is so he can give more time to his hobby, butterflies. CR has been a pillar of strength for the Patient Board and for his representation of communities within East Staffordshire. His successor will be known in February. Attached to these minutes is the Patient Board report for Sept – Dec 2019 which gives full details on the work carried out by the Patient Board and District Group during that time, Attachment (ii).

# (iii). District Group

The meeting does not take place until the following day, 16<sup>th</sup> January. This is also the AGM followed by the election of the officers to serve during 2020. Full details on the 2019 activities of the District Group can be found in attachment (iii) of these minutes.

# (ii). Virgin Care, (VC).

As mentioned in at the last meeting VC, had now given notice on withdrawing from the remaining part of the Improving Lives contract with the termination date of 31st March 2020. The new contract for the community services, which will run for 12months from 1<sup>st</sup> April 2020, is the Midlands Partnership Foundation Trust, (MPFT), which is part of the NHS. The two organisations are working closely together over the next 3 months as part of the handover of the services.

# (ii). National Association for Patient Participation, (NAPP)

The monthly e-bulletins have been circulated to all our members. The 2020 membership fee has been paid and the Secretary, JB, is awaiting the certificate.

# 9. Virtual Group Update.

No further update since the last meeting.

# 10. Quiz Night and Dates for 2020

There have been no further quiz nights since the one in November. Throughout 2019 the monies raised totalled £1543.40 giving a grand total of £7571.26 since the start of these quiz nights

- · Carry out a Patient Survey.

This was carried out late October / early November. In terms of people taking part, 541, it was by far the best survey we had undertaken. All the information gathered has now been written up. The members and the Practice have received the draft report and a meeting will be held February 2020 to go through the findings. Meanwhile, the draft report to date will be placed into the waiting room for people to review.

#### **Additional Achievement**

In May 2019 the Forum had been shortlisted as a finalist to receive an award at
the Annual Volunteer Star Awards. This was for the category of East Staffordshire
Volunteering Support for Young People by a Team or Individual Award and it had
been based on our previous work with Year 10 students at the deFerrers
Academy. This was an evening celebration aimed at publicly recognising and
celebrating the valuable contribution volunteer's play in supporting our
community.

At the awards ceremony in June we were proud to chosen as the winners of this award. In addition, the Forum Secretary received the Volunteer of the Year Award.

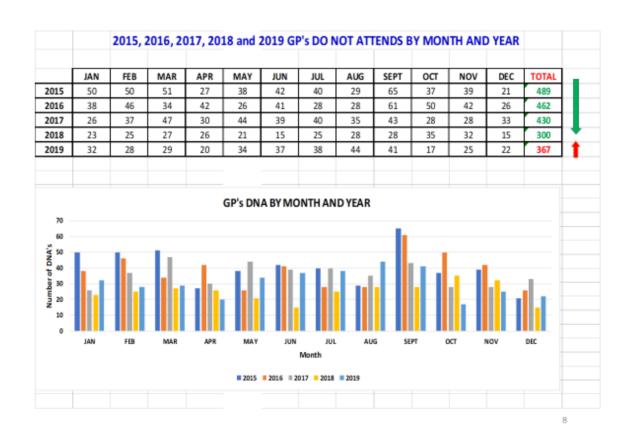
During the time of the survey an additional 74 Patients signed up for this service.

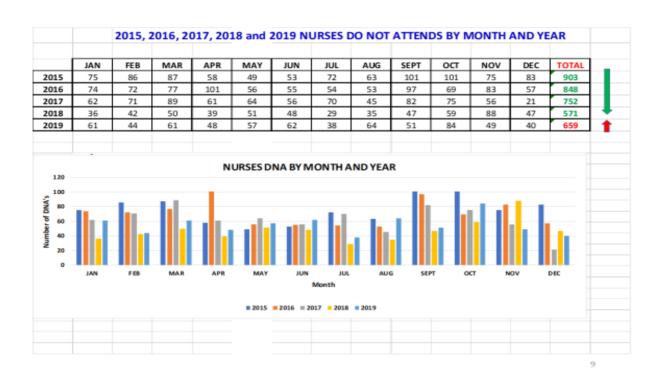
### The Patient Forum.

# Report from the East Staffordshire CCG Patient Board covering the September - December 2019 Meetings

### Introduction

This report is based on the Patient Board, (PB), meetings that were held on 10th September 8<sup>th</sup> October 12th November and 10th December 2019, (there was no meeting in August due to holidays).

This report has been submitted by the Chair. All meetings were conducted in accordance with the audit best practice recommendations. The chair would like to thank John Bridges for his input in compiling this report.

The Board, who meet every month, have representatives from Patient Participation Groups, the Voluntary Sector and senior members of the CCG. As mentioned in the previous report going forward it is envisaged to have a closer association with the Staffordshire South East and Seisdon Peninsular Patient Board and their PPI Lay Member has attended the meeting during this time period. This will continue throughout 2020 and vice versa with representative attending their Patient Board.

The Board have an Agenda which aims to cover every aspect of the health economy and the impact on the local communities within East Staffordshire decisions on a wider scale may have, for instance over the past time period the Agenda has covered:

- a. The Sustainability and Transformation Plan, (in Staffordshire known as Together We're Better),
- b. Feedback from the University Hospitals of Derby and Burton NHS Foundation Trust.
- c. Input from the CCG and wanting to ensure East Staffordshire still has a voice on its health economy.
- d. Virgin Care.
- e. Patient Stories, both positive and negative
- f. Input from the East Staffordshire District Patient Engagement Group which consists of patient representatives from the East Staffs Patient Participation Groups.
- g. Relevant speakers and guests.

### • Patient Stories:

At each meeting, we analyse the patient stories that are forwarded to us. These stories come via differing routes including the members themselves and the East Staffs District Patient Engagement Group.

For each story, concerning a GP Surgery or Hospital, clarification is sought to

ensure that the person concerned has followed the GP and Hospital reporting procedures. They are then actioned in accordance with their content. Over the months there have been a number of stories discussed at the meetings both of a positive and negative nature and actioned accordingly.

There has been occasions when the information received is deemed to of such a serious nature it is escalated immediately to the Chair of the Patient Board, Chris Ragg, who then escalates to the Joint Quality Team.

On the negative side the Board still do not receive total feedback on actions taken on the escalated stories.

### University Hospitals of Derby and Burton

As mentioned in the introduction to this report the Board are keen to ensure that the new Trust is maintaining the required standards regarding communication, patient involvement, new clinical pathways going forward and what is going on in involving / securing the community hospitals futures. The report for January -July indicated that to ensure this was being met a senior member of the hospital team at Burton would attend each Board meeting to give an update on both the above and other criteria the Board wish feedback on. This is a 30min slot on the Agenda with the person only present to give the feedback.

This started in June and has continued since with the Director of Nursing

(Operations), Queens Burton, Jim Murray attending the meetings. As required JM is also accompanied by a member of the hospital team who would be involved in the matters the Board wished to discuss.

Over the time period of this report the discussions have been around the following:

# September

- a. Jim Murray was accompanied by a member of the Project team, Lee Sharrard, who gave on the current and proposed work ongoing across the Trust especially in the areas of Cardiovascular and Endoscopy.
- b. Overview of the Trust wide patient and public engagement process.
- c. Plans for a mock CQC inspection over two days during November
- d. The Trust appointing a new Chair, Dr Kathy McLean OBE, following the retirement of John Rivers.

The Board proposed the following updates for future meetings UHDB targets set, UHDB performance, Patient Stories, PALS, Patient Reference Group update.

### **October**

- a. Jim Murray was accompanied by the Deputy Divisional Director for Surgery, Clare Chisholm.
- b. CC gave an update on the improvements in the surgical departments following the merger. These included, more outpatient appointments in Lichfield and Tamworth, more support into Burton in terms of tertiary and specialist, a vascular clinic at Tamworth and care pathway for hands, spinal injections and pain management again at Tamworth
- c. Update on the building work at the side of the Treatment Centre in Burton. This is for more orthopaedic care.
- d. Discussion on a wide range of topics including Pharmacy services, discharge procedures, future of the Breast Clinic and staffing for the new facilities planned.
- e. Positive and open input.

### **November**

- a. Jim Murray was again accompanied by Lee Sharrard of the Project Team.
- b. Update on the proposed stroke pathway and consultations that had taken place within the communities. Final decisions are currently on hold due to Purdah, but the new pathway should be in place within the 2020 calendar year.
- c. The Board asked if there were Patient Groups at UHDB and where they involved in the Trusts projects? This to be investigated and fed back.
- d. The Board again stressed the importance of communication to the wider communities especially when "change" was involved.

# • East Staffordshire Clinical Commissioning Group:

The Board have monthly feedback from Governing Body and discuss and action all matters that have been escalated down to the Patient Board. During the period covered by this report the Board has received input on the following:

- a. The East Staffordshire CCG's Restructuring plans and the set-up of Committees in Common.
- b. The effect of the 6 Staffordshire CCG's voting against becoming "one" and the possible reaction from NHS England.
- c. Concerns over the lost connection that existed before Committees in Common. As an example, the loss of the specific local East Staffs CCG Governing Body Meetings that the public could attend. The Board will be closely monitoring the effect the changes have had on the tight, efficient running of the CCG before the changes
- d. The situation regarding Virgin Care and the Improving Lives Contract.

# • East Staffordshire District Patient Engagement Group

The report covers the period from August – December 2019 as there was a meeting held in August. With all the changes and consultations going on throughout 2019 the group meetings have continued to be held every six weeks.
